TERMS AND CONDITIONS OF THE CONTRACT

- 1. The Contract will be for a period of one year with effect from the date of acceptance of this letter and the rates accepted are exclusive of GST which will be paid on actual basis based on documentary evidence of payment.
- 2. The Vehicle should be in excellent condition and the year of manufacture of the vehicle should be 2016 or later.
- 3. The Vehicle should be registered with state transport Authority and should have current /valid permit/Insurance.
- 4. Actual Parking charges/Toll taxes/entry taxes in connection with the official duty will be reimbursed along with the bill on production of original receipts.
- 5. Other liabilities like charges of driver, repair and Maintenance of Vehicles, Insurance, petrol/diesel/Electricity, oil and other incidental expenses etc. shall be borne by the supplier.
- 6. The Vehicle will have to be replaced/arranged by the contractor in case of break down/accident.
- 7. The driver should always have his license, registration certificate of Vehicle, Vehicle insurance, pollution free certificate and other such documents ready as required by the Government authorities for Inspection.
- 8. The contractor must have 24 hours working telephone/fax system so that the requirement of vehicle can be met at short notice at odd hours or holidays.
- 9. Energy Management Centre shall not be responsible for damage of any kind of Mishap/accident/injury caused to the driver performing duty for the centre. All liability, legal or monetary, shall be borne by the supplier.
- 10. The Vehicle deployed for EMC shall at no point of time carry any person other than personnel authorized by EMC. The vehicle once reported for duty shall not leave the premises without prior permission of the concerned officer.
- 11. Kilometer of the journey will be calculated from the starting point of journey by the officer and to the end of the journey by the officer. No additional Kilometer will be considered for the trip from garage to the place of duty and back to the garage.
- 12. Out station Bata to driver at the rate of 250/- per day, if the trip exceeds eight hours or 100 Kms. No Bata will be paid for journey within the city limit.
- 13. The trip sheet has to be got signed by the concerned officer who used the vehicles as and when the journey is performed and it should be attached with bill.

- 14. A log book should be maintained by the driver and the kilometer of each journey should be got attested by the concerned officer who used the vehicle.
- 15. Payment after Submission of the bill will be made within 15 days after proper verification and recommendation of the officers concerned.
- 16. Consecutive late arrivals and unhygienic condition of the vehicle will lead to cancellation of the contract.
- 17 The contract can be terminated by the supplier by giving three months notice whereas EMC can terminate the contract by giving 15 days notice.
- 18. No advance payment in any case would be made to the supplier.
- 19. In case a vehicle is requisitioned and the same does not reach at the appointed time and place, EMC will be free to hire another vehicle from open market and the additional expenses on this account will be deducted from the pending bills/security deposit. Besides, a Penalty @200/ will be charged for every such lapse.
- 20. Vehicle will be hired according to the requirement of the centre.
- 21. Performance Security: A performance security in the form of Bank Guarantee/Demand Draft for an amount of Rs 20,000/- issued by Nationalised bank in favour of the director, EMC with a Validity period up to 31-08-2022. In the event of breach of contract, performance security shall be forfeited.
- 22. Agreement in the stamp paper worth Rs 200/- is to be executed within 15 days from the date of commencement of contract.
- 23. The contract can be extended for a further period of 3 months on the same terms and conditions on mutually agreed basis at the discretion of EMC.
- 24. The Bidders should submit their Price Bid according to Annexure- 1 attached with the Tender Notice and the experience proof.
