Performance Security

- The successful bidder shall, on receipt of the work order, deposit a sum equivalent to five percent (5%) of the value of the contract as security deposit for a period of one year from the date of delivery of the pump sets.

In such case the 5 % of the contract value will only be paid after two years from the date of delivery.
